



## Prop 65 Vendor Compliance

Boscov's regards our vendors as partners in ensuring that all Boscov's merchandise is safe for our customers. In pursuit of that goal, Boscov's Purchase Order Terms and Conditions clearly states that as a Boscov's business partner, it is your responsibility to notify us of any product or material that you provide to Boscov's, that is known by the State of California, under California Proposition 65 (Prop 65), to be harmful to individuals.

Warning Requirements - According to California Health and Safety Code Section 25249.6, no person in the course of doing business shall knowingly and intentionally expose an individual to a product containing chemicals at a level known to the state of California that cause cancer, birth defects or other reproductive harm without first providing a clear and reasonable warning. The California Attorney General's Office has indicated that, in their view, distributors of products have a duty to inform their customers of the warning requirement and to take reasonable steps to ensure their customers are properly providing the warning to the ultimate purchaser of the products.

We Need Confirmation From You - An individual in a position of authority within your company and with adequate knowledge of the products supplied, to confirm your receipt of these warning materials and instructions from us. We also need your confirmation to know your company will carry out its duty to provide Proposition 65 warnings to end users on products or packaging and to provide Boscov's Department Stores LLC with warnings to post in online product listings, in the manner stated above. **To ensure compliance, please complete the Proposition 65 Vendor Statement (Attachment A), then scan and email it to Prop65@Boscovs.com.**
